III. Routine Matters

IV. Leadership Reports

- A. President's Report: A reminder that the teacher scholarships for the semester are due at the end of this week. Winners will be pulled at the next Board meeting through a lottery system. Applications for spring semester will be accepted immediately. Molly is continuing to visit buildings; she will visit Horizon High School in the spring. MPS Foundation campaign: The 2009 total was \$44,349 up from \$42,187 which is a 6% increase; the 2009 donor total was 1074 up from 943 which is a 10% increase. First Nebraska Educator fliers are available for distribution at school.
- B. Vice President's Report: Mike Foyt was absent.
- C. UniServ Report: Remind members that if they have questions/concerns regarding observations or evaluations to contact Mike Wiesen and/or Molly. Governor Heineman has called a special session to cut the budget and school aid is on the table; any cut will affect us. Last spring we received NEA grant money, and we used it to contact nonmembers with 2-5 years experience; 90 teachers were contacted, 26 of those teachers joined MEA this year. We may want to consider doing this again in the spring. Thank you to those who helped make phone calls.
- D. Metro District Board Report: LCCC minutes are currently online through the NSEA website (www.nsea.org) under Metro District. Lincoln, Nebraska is hosting the Special Olympics USA National Games in July 2010; those interested in volunteering can get information from the NSEA website as well. There is a Teacher Town Hall meeting to address No Child Left Behind at Westside Community Center on Thursday, November 12th from 5:30-7:30 p.m. Roger Breed (Nebraska Commissioner of Education), Marilyn Peterseon (Director of Federal Programs), and Congressman Lee Terry will discuss NCLB and answer questions from teachers.
- E. LCCC Report: Millard School Board met to approve their poverty and diversity plans; the state and Learning Community still have to approve these. Molly will have more info about this at the next meeting. The previous LCCC meeting addressed student movement between districts.
