# V. Leadership/Staff Reports

- A. President's Report:
  - a. Molly is on the NSEA Alternative Compensation Committee. NSEA is working on getting information to all districts on adding something to district contracts that reflects alternate compensation, i.e. performance pay.
  - b. The Extra Duty Committee has one more meeting in which they will share their recommendations with the Negotiations Team.
- B. Vice-President's Report: No report
- C. UniServ Report:
  - a. The district can increase a teacher's FTE without notice; that teacher then has to make a decision as to whether or not they want to go full-time. Any decrease in a teacher's FTE is considered a Reduction in Force (RIF). If this happens, contact Mike Wiesen, Millard's UniServ Director, to receive support. Also contact Mike with any other member rights' concerns you have.
  - b. If we lose collective bargaining rights, the district will be able to decide how much we get paid; they will also be able to do away with tenure. The Millard School Board is planning on voting tonight to support the Legislative Bills which abolish the authority of the Committee of Industrial Relations (CIR) and collective bargaining rights.
- D. LCCC Report (Matt Heys):
  - a. The LCCC is not supporting the focus school in South Sarpy (the green school).
  - b. District 4 is meeting this week.
- E. GRC Report (Paul Schulte):
  - a. Paul attended a NSEA Legislative Focus Session on January 21<sup>st</sup> which identified four main goals: Funding for Pre K-College education, preserving the retirement system, enhancing the lottery-funded tuition reimbursement, and preserving collective bargaining.
  - b. There are six state senators that represent Millard. NSEA is asking that we try and hold a meeting at the local level to discuss issues with our Senators. State Senator John Nelson is one of the main NSEA targets that they would like MEA to meet with. He represents Millard and has written a bill to abolish collective bargaining as well as introduced a constitutional amendment to abolish the CIR. We have a strong ally in State Senator Steve Lathrop, who also represents the Millard area. He's the chair of the Business and Labor Committee, which will be dealing directly with the CIR bills.
