 - E. Legislation / Advocacy Brian Mikkelsen w NSEA ~ Congratulations shared re: levy renewal. Sign up for legislative update at NSEA.org to receive Jason Hayes, Lobbyist, legislative update. 2 issues - 1) state aid has been discussed and there will probably be many changes; Tim Royers playing an active role. We will be able to work with it in the future but school board voting is critical and 2) legislature returns this week still many issues to take up time. LB753 - Tax Credit Vouchers - Ne one of only 2 states that doesn't have funding for private schools. Will be discussed this week in the general file. Need to let senators know thoughts on this - email links available at NSEA.org. AZ dealing with repercussions of voucher scheme. Ready for referendum to get vote on ballot via petition. Public wants public money going to public schools. Accredited and approved pirate schools are open to receive funding. Amendments proposed nondiscrimination clause and same rules - but they failed. Start thinking of 100 names that would sign a petition to get on the ballot. Contact Brian directly at any time.
