- A. New Contract Issues (Salary Calculations and VSP)
 - a. If you have questions, please go through the Human Resources link on the MPS website or email millardhumanresources@mpsomaha.org
 - i. Compensation questions: Gains in salary are eroded due to the increase in retirement.
 - ii. Extra duty is not currently in pay.
 - iii. To access the worksheet to calculate salary with the new method
 - 1. Go to the MPS website.
 - 2. Click on the Human Resources link.
 - 3. Click on the Compensation/Benefits/New Hire Paperwork link.
 - 4. Click on Teachers.
 - 5. Click on Teacher Salary Work Sheet.
 - iv. The Employee Access Center provides historical information/data.
 - 1. Log on to the EAC.
 - 2. Click on Salary and Benefits.
 - 3. Scroll to the bottom of the page and click on Historical Salary and Benefits.
 - v. VSP eligibility: If you currently qualify for VSP, this is the last year to take VSP without the cap, especially if you are currently 55 years of age, and have at least 10 years in the district. Next year, the qualifications will change to 55 years of age, 20 consecutive years in the district, and a cap of \$100,000. The window of VSP eligibility will also drop from 10 years down to 5 years. If you have questions about VSP, be sure to contact the HR email.
