    - 1. SSL Encryption " logging into a website or app with increased security (i.e., banking) or student access to YouTube. Will not decrypt banks, insurance, EAP, private emails, etc. Health data will be un-viewable.
    - 2. School violence walkout plan " 3/14 in conjunction with Women's March made into a broader message than just the school shooting, 3/24 student one. Work with administration if don't, could lead to reprimand or discipline. No interruption to student day is allowed. Administrators will go out and may ask staff to supervise because we have to make sure students are safe, honoring 1st amendment rights of students. How to answer student questions? refer back to administration.
    - 3. Communication with staff on potential school violence " all staff not informed when safety and security is threatened. DSAC will relook at the procedure of notifying all staff and protecting student privacy. Sugar-coated information going out to parents and/or staff?
    - 4. Middle School Transition Plan " by end of Feb, DSAC would have mtgs in all of the middle schools. Not completed in 3 schools. All world language teachers will have jobs, maybe not in their endorsed area or at their current school. Elective classes being developed with additional classes added each year. Scheduling? Letter of Intent will go out this week. Teachers don't know what they are teaching next year. Equal opportunity for positions? Right to place/reassign is allowed. Let Paul know if there are members who are impacted. Provisional teachers assigned to classes? 10% allowed total to teach with provisional certificates across the district.
