Meeting called to order at 4:33 p.m.

 - Negotiations Report—Tim ~ ALMOST DONE! District accepted last week agreement in principal still ironing out language, total package agreed upon, 2 year contract. Will have it done by end of the school year. Free to share that it's a 2 year agreement. Video and PDF will be emailed out and Negotiations Team will host 2 mtgs – MNHS & MSHS. There will NOT be an additional day in our contract. 80% did not think an additional day would be helpful. Survey provided the hard evidence that the Team was speaking for the membership.
 - Early Enrollment continues through May 31 ~ Please continue to talk with colleagues that might be potential members (never have been part of NSEA or any other state association). So many times, they say they haven't been asked. We have to ask! They would start paying in October by EFT, but would have member benefits starting the day they sign up.
 - 3. FMLA and Snow Days ~ We had 9 members that were ready to move forward with a grievance against the district because the district was going to take away 2 days from their leave bank, even though for the rest of us we were forgiven the 5th and 6th snow day. Even if you had put in for a day off, they didn't charge you for that day. With a grievance, you have 10 business days to submit your grievance. We were on day 9 when Paul went and requested a meeting with Kevin Chick. Paul shared that when talking with NSEA legal team, they said that it was discrimination against those on FMLA and the only thing they could do is if they charged everyone two days. Paul shared that interpretation with Kevin as well as sharing that this wasn't communicated with those before taking FMLA. Within 30 minutes of the meeting, Kevin texted stating that "Due to the uniqueness of the weather year, we will give on the FMLA grievance. If any docking already occurred, we will reimburse (we don't think it did, but we are checking). No future docking will take place. Jake is working on an email to send to the affected employees. We will also work on a communication in our FMLA process so people know of this possible situation at the beginning of the year. Thanks for bringing this to me today.". This was a huge win for the 10 members that contacted us, as well as the 35 educators that were out on FMLA. If you know of anyone currently out on FMLA, be sure to ask them if they are a member and if not, if they would like to consider joining because of the MEA work on behalf of those out on FMLA.
