- G. Insurance Coverage
 - 1. There have been a number of rumors about Coventry dropping major providers in the Omaha area. These may be in regards to the ACA exchange program, but because MPS is self funded, we have our own plan.
 - 2. Paul contacted Chad Meisgeier and will forward his email discussing Coventry and the concerns about coverage. Chad said that currently there has been no change and Coventry would have communicated that with him. It's also important to note that there is a clause in the MPS-Coventry agreement which allows MPS to leave immediately without penalty if there is an interruption or major change to the services currently provided.
- V. Action Items/Unfinished Business
 - A. First Reading of Constitutional Amendments
 - 1. The proposed changes to the MEA Constitution would establish how a contract is ratified. Currently the Negotiations t=Team makes a recommendation to the Board of Directors, then the Board makes a recommendation to the BR Council, and then the BR Council makes a recommendation to the membership. The membership then votes to ratify the contract.
 - 2. If the Negotiations Team reaches a point where they can't come to an tentative agreement with the district, then they would make a recommendation to the Board of Directors to request NSEA and their legal team to begin Resolution Officer Proceedings. This recommendation would then be taken to the BR Council, where they would have the authority to turn the negotiations over to NSEA and their legal team.
 - 3. Due to the changes in the law that govern negotiations and the bargaining calendar, MEA needs to update our Constitution to

- A. President's Report
 - a. Paul attended the Advocacy Conference in GI with Marsha Edquist and Tyler Berzina. The constitutional changes were brought about through discussions with NSEA staff and the legal team.
 - b. Paul attended the SEAN Outreach to Teach as the NSEA SEAN liason There were over 125 college students from across the state doing projects at Lewistown Public Schools, including building a greenhouse, painting, landscaping, and replacing ceiling. The students were in for a surprise when they came to school on Monday!
 - c. Paul is serving on the search committee for the new exec director of the Foundation. The committee has narrowed it down to 5 candidates. They hope to finish soon and have the new hire in place by January.
 - d. He attended boundary meetings last week. The purpose of the town hall forums was to collect info from the community. The committee will then review the data and make their recommendation to Dr. Lutz, who will then make his recommendation to the school board on November 18th. Then the school board vote is scheduled for the December 2nd school board meeting. There were questions about how the boundary

committee was formed, as well as how this might affect staff across the district and the process of moving staff.

- e. Paul attended his first MPS Staff Evaluation committee meeting. It will be a two year implementation, focusing on NDE recommendation as well as the committee researching best practice, including looking at rubrics, peer evaluations, and how best to update the process
