 - 2. Listing of new teachers in Millard who are not members as of last week was distributed. Matched BRs to potential members in bldg or matched people based on assignments. Please touch base about 1x/month with your non-member buddy. Please help fill in blanks and provide your name at front table or let us know if there is someone you are buddying with that you need changed. Can call or email. CANNOT SOLICIT MEMBERSHIP OVER SCHOOL EMAIL. Please call/email with ~ make sure things are going okay, school year started off okay, topic this month = they know and understand how their paycheck works, how to check if it is correct...  - 3. Changes in law regarding grievances must exhaust every action before a referral to district court.
