  - b. ProCom Report
    - i. RTI+I
      - 1. The district recommends that school improvement teams should have input on how points are used for staff allocations and what interventions are offered at the building level.
      - 2. At January cluster meetings ask if members are a part of SIT teams in each building.
    - ii. Wednesday Planning Time
      - Elementary teachers are concerned about the number of responsibilities they have on Wednesday afternoons.
