 - 1. The survey has included the same questions for the last three years.
 - The general trend is that high school staff member results show higher engagement each year, middle schools fluctuate each year and elementary schools are showing lower engagement levels.
 - 3. Survey results will be considered when designing site plans.
 - 4. There was some discussion regarding the positive impact of praise coming from colleagues as well as administrators.
 - ii. MIM and the Evaluation Process
 - 1. For a period of time, Millard Public Schools utilized teacher-directed indicators on evaluations. Most recently, our teacher evaluation indicators have been student-response driven.
 - Dr. Sutfin discussed the fact that we want to continue to exceed state standards and will be implementing a blended model beginning in the 2015-2016 school year. This new model will include Appraisal, Continuous Growth I and Continuous Growth II phases, emphasizing instructional coaching as well as student data.
