For efficiency – 7 period day, teachers teacher for 6 of them, late start on Mondays for PLCs and Team meetings, HAL/Intervention/Electives/and Exploratories, hexters or quarters (?), Heather and Kevin coming out to bldg. mtgs in February. Paul recommends that impacted teachers take positions that are offered and then watch for additional opening in the spring.
    - 3. Mandy explained that teachers can teach out of endorsement, continuing contract law applies teachers can't be riffed. Members need to contact Mandy: RIF word used, call right away; cannot talk to non-members, encourage to join; teachers cannot direct petition the board – Kevin will arrange mtg with Jim to avoid people wanting to talk at board mtg; superintendent has the purview of curriculum, union has no say; we cannot rally parents or students / coach / or get on social media – risk disciplinary action; and parents can approach board on Monday but teachers cannot be a part of it – refer to district website.
